LETTER FROM THE BOARD

INTRODUCTION

At the 2025 AGM, general unconditional mandates were given to the Directors to exercise all powers of the Company to:

- (a) allot, issue and deal with the Shares with an aggregate number of Shares not exceeding 20% of the number of Shares in issue as at that date;
- (b) purchase the Shares with an aggregate number of Shares not exceeding 10% of the number of Shares in issue as at that date; and
- (c) add to the general mandate for issuing Shares set out in (a) above the number of shares purchased by the Company pursuant to the repurchase mandate set out in (b) above.

The above general mandates will expire at the conclusion of the AGM, unless renewed at that meeting.

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the AGM for (i) granting the general mandates to the Directors to allot, issue and deal with new Shares and repurchase Shares; (ii) the re-election of the retiring Directors; and (iii) the re-appointment of independent auditors.

PROPOSED GRANT OF GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

3 (three) respective ordinary resolutions will be proposed at the AGM for the purposes of granting the general mandates to the Directors:

- (a) to allot, issue and otherwise deal with additional Shares (including any sale or transfer of Treasury Shares out of treasury) with the aggregate number of such Shares not exceeding 20% of the number of Shares in issue (excluding Treasury Shares, if any) at the date of passing the resolution approving the Issue Mandate (subject to adjustment in case of any conversion of any or all of the Shares into a larger or smaller number of Shares after approving the Issue Mandate);
- (b) to repurchase Shares with the aggregate number of such Shares not exceeding 10% of the number of Shares in issue (excluding Treasury Shares, if any) at the date of passing the resolution approving the Repurchase Mandate (subject to adjustment in case of any conversion of any or all of the Shares into a larger or smaller number of Shares after approving the Repurchase Mandate); and
- (c) to add to the Issue Mandate set out in (a) above the number of Shares repurchased by the Company pursuant to the Repurchase Mandate.

The full text of these resolutions are set out in Resolution 6 (Issue Mandate), Resolution 7 (Repurchase Mandate) in the notice of the AGM contained in pages 15 to 19 of this circular.

LETTER FROM THE BOARD

The aforesaid mandates, unless revoked or varied by way of ordinary resolutions of the Shareholders in general meeting, will expire at the conclusion of the next annual general meeting of the Company, which will be convened on or before 30 September 2027.

As at the Latest Practicable Date, a total of 229,303,213 Shares were in issue. Subject to the passing of the proposed resolutions in relation to granting the Issue Mandate and the Repurchase Mandate to the Directors and on the basis that no Shares will be issued and/or repurchased by the Company prior to the AGM, the Company will be allowed to issue (i) a maximum of 45,860,642 Shares; representing 20% of the aggregate number of the issued Shares (excluding Treasury Shares, if any) as at the date of the AGM under the Issue Mandate; and (ii) repurchase a maximum of 22,930,321 Shares, representing 10% of the aggregate number of the issued Shares (excluding Treasury Shares, if any) as at the date of the AGM.

In accordance with the requirements set out in the Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing requisite information to consider the Repurchase Mandate subject to certain restrictions, which are set out in Appendix I to this circular.

PROPOSED RE-ELECTION OF RETIRING DIRECTORS

To comply with the Corporate Governance Code and Corporate Governance Report under Appendix C1 to the Listing Rules and in accordance with the Article 108(a) of Articles of Association, Mr. Pan Yimin (“**Mr. Pan**”) and Ms. Du Yun (“**Ms. Du**”) will retire by rotation and being eligible, will offer themselves for re-election at the AGM.

In proposing candidate of independent non-executive Director for re-election at the AGM, the Nomination Committee of the Company has considered Ms. Du’s past performance, her written confirmations of independence to the Company under Rule 3.13 of Listing Rules as well as her skills, backgrounds, knowledge and experience.

In this respect, the Nomination Committee had evaluated the performance of the retiring independent non-executive Director and found her performance satisfactory. The Nomination Committee has also assessed the independent non-executive Director’s written confirmation of independence under Rule 3.13 of Listing Rules, and is satisfied that Ms. Du remains independent. Taking into account her respective professional knowledge, experience and independent opinions that will be bring to the Company, the Nomination Committee also believes the continuous appointment of Ms. Du as an independent non-executive Director is seen as beneficial to the Company and is in line with the Company’s director nomination policy and board diversity policy. In addition, the Board is of the view that the retiring independent non-executive Director would bring to the Board her own perspective, skills and experience, as further described in her respective details in Appendix II to this circular.

Given her unique and diverse background, skills and experience as discussed in Appendix II to this circular, the Company considers that the retiring independent non-executive Director is a highly valued and respected member of the Board, and can contribute to the diversity of the Board with her strong and diversified educational backgrounds and professional experience in her expertise, including her in-depth knowledge in commercial and general management, professions in legal and accounting and audit and connections in various industries.

The retiring Directors had abstained from voting on the resolutions of their respective nominations at the Nomination Committee meeting.

Details of the retiring Directors proposed to be re-elected as Directors at the AGM which are required to be disclosed by the Listing Rules, are set out in Appendix II to this circular.

PROPOSED RE-APPOINTMENT OF INDEPENDENT AUDITORS

The Board (which agreed with the view of the Audit Committee) recommended that, subject to the approval of the Shareholders at the AGM, Asian Alliance (HK) CPA Limited be reappointed as the independent auditors of the Company for the financial year ending 31 March 2027.

The estimated audit fee payable to Asian Alliance (HK) CPA Limited for the audit of the consolidated financial statements of the Company and its subsidiaries for the financial year ending 31 March 2027 is expected to be approximately HK\$1.9 million. Such fee has been determined after due consideration and arm's length negotiations between the Company and Asian Alliance (HK) CPA Limited, taking into account, among other things, historical audit fees, prevailing market rates, the complexity and business plans of the Group, the expected scope of the audit, the audit timetable, and the auditor's resources required. The estimated audit fee has been determined on the basis that no material changes are expected in the Group's operations, accounting policies or regulatory environment during the financial year, and that the Company will provide timely and adequate assistance and information as reasonably required for the audit.

As Asian Alliance (HK) CPA Limited is relatively familiar with the Group's financial position and affairs, the Board considers that the estimated audit fee agreed with Asian Alliance (HK) CPA Limited is fair and reasonable, taking into account the facts and circumstances known as at the Latest Practicable Date, and that the audit related work in respect of the Group for the year ending 31 March 2027 will be performed more efficiently by Asian Alliance (HK) CPA Limited, which is in the best interests of the Company and the Shareholders as a whole.

Accordingly the Directors, together with their associates, intend to vote in favour of the relevant resolutions in respect of their respective shareholdings in the Company and recommend the Shareholders to vote in favour of such relevant resolutions to be proposed at the AGM.

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide the requisite information to you for your consideration of the Repurchase Mandate.

SHAREHOLDERS' APPROVAL

The Listing Rules provide that all repurchase of securities by a company with its primary listing on the Stock Exchange must be approved in advance by an ordinary resolution, either by way of general mandate or by specific approval in relation to specific transactions.

SHARE CAPITAL

As at the Latest Practicable Date, 229,303,213 Shares were in issue and fully paid and the Company did not have any Treasury Shares.

Subject to the passing of the relevant ordinary resolutions and on the basis that no further Shares are issued and repurchased prior to the AGM, the Directors would be authorized under the Repurchase Mandate to repurchase during the period in which the Repurchase Mandate remains in force, a maximum of 22,930,321 Shares, representing 10% of the number of Shares in issue (excluding Treasury Shares, if any) as at the date of passing of the resolution.

REASONS FOR REPURCHASE

The Directors believe that granting of the Repurchase Mandate is in the best interests of the Company and its Shareholders as a whole. When exercising the Repurchase Mandate, the Directors may, subject to market conditions and the Company's capital management needs at the relevant time of the repurchase, resolve to cancel the shares repurchased following settlement of any such repurchase or hold them as Treasury Shares. Shares repurchased for cancellation may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets value per Share and/or earnings per Share. On the other hand, Shares repurchased and held by the Company as Treasury Shares may be resold on the market at market prices to raise funds for the Company, or transferred or used for other purposes, subject to compliance with the Listing Rules, the Articles of Association, the Companies Act of the Cayman Islands and/or any other applicable laws, as the case may be. Share repurchase will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole.

For any Treasury Shares deposited with CCASS pending resale on the Stock Exchange, the Company shall (i) procure its broker not to give any instructions to HKSCC to vote at general meetings of the Company for the Treasury Shares deposited with CCASS; and (ii) in the case of dividends or distributions, withdraw the Treasury Shares from CCASS, and either re-register them in its own name as Treasury Shares or cancel them, in each case before the record date for the dividends or distributions, or take any other measures to ensure that it will not exercise any Shareholders' rights or receive any entitlements which would otherwise be suspended under the applicable laws if those Shares were registered in its own name as Treasury Shares.

FUNDING OF REPURCHASE

Any repurchase will only be funded out of funds of the Company legally available for the purpose of making the proposed purchases in accordance with the Company's Memorandum and Articles of Association, the Companies Act of the Cayman Islands and/or any other applicable laws, as the case may be.

EFFECT OF EXERCISING THE REPURCHASE MANDATE

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the Company's audited accounts for the year ended 31 March 2026) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the repurchase of Shares to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

DIRECTORS AND CORE CONNECTED PERSONS

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their respective close associates have any present intention, if the Repurchase Mandate is approved by the Shareholders, to sell any Shares to the Company or its subsidiaries.

No Core Connected Persons have notified the Company that they have a present intention to sell any Shares held by them to the Company or its subsidiaries, or have undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

DIRECTORS' OBLIGATION

The Directors will exercise the powers of the Company to make repurchase pursuant to the Repurchase Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands. Neither the explanatory statement in this Appendix I nor the Repurchase Mandate has any unusual features.

EFFECT OF THE TAKEOVERS CODE

If, as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the interest of the Shareholders, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 of the Takeovers Code as a result of a repurchase of Shares made.

As at the Latest Practicable Date, the following Shareholders were interested in 5% or more of the issued Shares as recorded in the register of the Company kept under Section 336(1) of Part XV (Disclosure of Interests) of the SFO:

On the basis of the current shareholdings of above Shareholders, an exercise of the Repurchase Mandate in full will not result in him/it becoming obliged to make a mandatory offer under Rules 26 of the Takeovers Code.

The Directors have no intention to exercise the Repurchase Mandate to such an extent that will result in a requirement of the above Shareholders, or any other persons to make a general offer under the Takeovers Code or the number of Shares in the hands of the public falling below the prescribed minimum percentage of 25%.

SHARE REPURCHASE MADE BY THE COMPANY

No repurchase of Shares has been made by the Company (whether on the Stock Exchange or otherwise) during the six months immediately preceding the Latest Practicable Date.

The Company confirms that the explanatory statement set out in this Appendix contains the information required under Rule 10.06(1)(b) of the Listing Rules and that neither the explanatory statement nor the Repurchase Mandate has any unusual features.

As required by the Listing Rules, the following are the particulars of the retiring Directors proposed to be re-elected at the AGM:

1. MR. PAN YIMIN (“MR. PAN”)

Mr. Pan Yimin, aged 50, was appointed as an executive director of the Company on 24 March 2021. He is also a member of each remuneration committee and investment committee of the Company. Mr. Pan was the president of Tianjin Dongfang Mingrui Investment Management Co., Ltd* since 2013 prior to joining the Company. Mr. Pan was the vice president of Interchina (Tianjin) Water Treatment Co., Ltd.* from April 2011 to March 2013, and a deputy manager of Heilongjiang Interchina Water Treatment from April 2009 to March 2011.
