Remarks (if any):

On 5 March 2019, the Company granted 51,100,000 share options to certain directors and employees under
Share Option Scheme adopted on 26 August 2014, with the validity period being 2 years from respective vesting
Dates. The 30,120,000 Options will vest immediately on the Date of Grant (from 5 March 2019 to 4 March
2021) (both days inclusive); and remaining 20,980,000 Options will vest 1 year after the Date of Grant (from
5 March 2020 to 4 March 2022) (both dates inclusive). Details of the grant of Share Options are set out in the
announcement of the Company dated 5 March 2019.
