Remarks (if any):

On 5 March 2019, the Company granted 51,100,000 share options to certain directors and employees under the Share Option Scheme adopted on 26 August 2014 (the "Share Option Scheme"), with the validity period being 2 years from respective vesting Dates. 30,120,000 Options were lapsed on 4 March 2021); and the remaining 20,980,000 Options were vest 1 year after the Date of Grant (from 5 March 2020 to 4 March 2022) (both dates inclusive). Details of the grant of Share Options are set out in the announcement of the Company dated 5 March 2019.

On 19 April 2021, the Company granted 46,492,000 share options to certain Directors, employees, and a Consultant under the Share Option Scheme. 16,892,000 Options were vested immediately on the Date of Grant (from 19 April 2021 to 18 April 2023); 14,800,000 Options will be vested on the first anniversary from the Date of Grant (from 19 April 2022 to 18 April 2024), and the remaining 14,800,000 Options will be vested on the second anniversary from the Date of Grant (from 19 April 2023 to 18 April 2024). Details of the grant of Share Options are set out in the announcement of the Company dated 19 April 2021.
