SUMMARY

- The Offer Price has been determined to be HK\$0.86 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.86 per Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other related Listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$60.9 million. For details regarding the use of net proceeds, please refer to the paragraph headed “Offer Price and use of net proceeds from the Share Offer” below.
- A total of 9,496 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 3,966,616,000 Public Offer Shares, equivalent to approximately 396.66 times of the total number of 10,000,000 Public Offer Shares initially available under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer — The Public Offer — Reallocation” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 100 times of the number of Offer Shares initially available under the Public Offer, 40,000,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares available under the Public Offer increases to 50,000,000 Shares, representing 50% of the total number of the Offer Shares initially available under the Share Offer.

The Offer Price has been determined to be HK\$0.86 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%).

Based on the Offer Price of HK\$0.86 per Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and the estimated other relating Listing expenses payable by the Company in relation to the Share Offer, is estimated to be approximately HK\$60.9 million. The Company presently intends to use the net proceeds from the Share Offer as follows:

- approximately 82% or approximately HK\$50.0 million of the net proceeds for the acquisition of additional machinery and equipment for foundation works (including but not limited to hydraulic casing oscillator, hydraulic excavator, piling rig, hydraulic crawler crane and other foundation works equipment) in the next four years to increase the Group's capacity to cope with the Group's expected business growth;
- approximately 10% or approximately HK\$6.0 million of the net proceeds for the hiring of additional staff, including two project management staff (including project manager and engineer) and nine machinery operators to be hired to increase the Group's capacity; and
- the remaining 8% or approximately HK\$4.9 million of the net proceeds will be used as general working capital of the Group.
