As more than 50% of the votes were cast in favour of each of the Resolutions, all the Resolutions were duly passed by way of poll as ordinary resolutions of the Company.

As at the date of the AGM, the total number of issued shares of the Company was 673,590,134 shares, which was the total number of shares entitling the holders thereof to attend and vote for or against the Resolutions at the AGM. There were no shares of the Company entitling the holders thereof to attend and abstain from voting in favour of the Resolutions at the AGM pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). No holder of the shares of the Company was required to abstain from voting at the AGM under the Listing Rules.

In addition, no party has indicated in the circular of the Company dated 21 August 2020 that he/she/it intends to vote against or to abstain from voting on any of the Resolutions at the AGM.

Tricor Investor Services Limited, the Company's Hong Kong branch share registrar, was appointed as scrutineer for the vote-taking at the AGM.
